

ALABAMA BOARD OF PARDONS & PAROLES

Open Public Meeting Minutes

November 13, 2025

A. Call to Order:

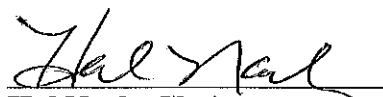

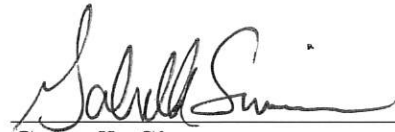
