Open Public Meeting Minutes

November 5, 2025

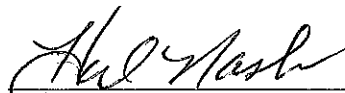

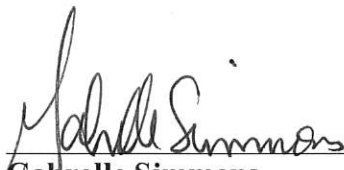

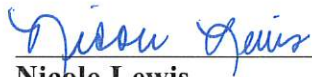
