



On May 28, 2020, the Board denied parole to Sonja Yvette Knight, AIS #162757. Following the denial, Bureau of Pardons and Paroles staff identified an error on the Board's action sheet denying parole, specifically a reset date not in compliance with Alabama Code Section 15-22-37. The aforementioned error did not affect in any way the denial of parole and was not considered by the Board when deciding whether to grant or deny parole per the statutory guidelines.

Therefore, the Board hereby votes to void the previously given reset date and resets the above inmate for 5/2022.
