

ALABAMA BOARD OF PARDONS & PAROLES

Open Public Meeting Minutes

October 28, 2021

A. Call to Order:

1. The Alabama Board of Pardons and Paroles called to order its open public meeting on this date at 9:12 A.M., 100 Capitol Commerce Blvd. Montgomery, AL 36117 for the purpose of conducting its regular parole/pardon hearings, as prescribed by Alabama Code, Title 15, Chapter 22. Board members present were: Leigh Gwathney, Chairman and Dwayne Spurlock, Board Member and Darryl Littleton, Board Member.
2. The Board met to discuss the attached agenda, with the action taken by the Board recorded by the Board's secretary, Nicole Lewis.







The Alabama Board of Pardons and Paroles met on this 28th day of **October 2021**, in open public meeting, at which time the following Board Members were present: Leigh Gwathney, Chair; Dwayne Spurlock, Associate Member; and Darryl Littleton, Associate Member.

On September 21, 2021, the Board considered Timothy Nicholas Brady, AIS 208115 for parole and voted to grant parole. At the time, Mr. Brady was not eligible for parole consideration. Mr. Brady was placed on the parole consideration docket in error because of incorrect information on the Alabama Department of Corrections' (DOC) timesheet.

When Mr. Brady was scheduled for parole consideration, the DOC timesheet showed Mr. Brady serving a single prison sentence of 130-months with an EOS date of 11/23/2025 in 57-DC-2013-000391. Prior to Mr. Brady's release on parole, it was discovered that he was serving a second sentence on another conviction.


When parole consideration was scheduled, the DOC timesheet had incorrectly listed Mr. Brady's sentence in 57-CC-2019-000139 as a 21-month sentence and that the sentence had been completed. However, the timesheet should have reflected a 21-year sentence with an EOS date of 5/2/2040. When DOC corrected the timesheet, Mr. Brady's parole consideration date was recalculated. He is **not** eligible for parole consideration until 6/2026.

Therefore, the Board **ORDERS** the following: that the Bureau calculate the initial parole consideration date for Mr. Brady based on his corrected timesheet and that the Board's order dated 9/21/2021 granting parole be rescinded.
