

ALABAMA BOARD OF PARDONS & PAROLES

Open Public Meeting Minutes

October 26, 2023

A. Call to Order:


Based on new information provided to the Board that William H. Gates, AIS# 106358 was recently deceased, the Board voted unanimously to remove his case from the parole consideration docket.






