ARE YOU READY TO VOTE?

YOU MAY QUALIFY FOR A CERTIFICATE OF ELIGIBILITY TO REGISTER TO VOTE IF:

- YOU HAVE ONE OR MORE FELONY CONVICTION(S) FROM ANY STATE OR FEDERAL COURT.
- YOU HAVE NO PENDING CRIMINAL FELONY CHARGES.
- YOU HAVE PAID ALL FINES, COURT ORDERED COSTS, FEES AND RESTITUTION ORDERED AT THE TIME OF SENTENCING ON DISQUALIFYING CASES IN FULL.
- YOUR SENTENCE HAS BEEN COMPLETED.
- YOU HAVE SUCCESSFULLY COMPLETED PROBATION OR PAROLE.

TREASON

***You may apply for a Pardon to be considered for the restoration of your Civil and Political Rights in all cases, except treason, impeachment, and cases in which a sentence of death is imposed and not commuted.*

ATTEMPT TO COMMIT AN EXPLOSIVE OR DESTRUCTIVE DEVICE OR BACTERIOLOGICAL OR BIOLOGICAL WEAPONS CRIME
CONSPIRACY TO COMMIT AN EXPLOSIVES OR DESTRUCTIVE OR BACTERIOLOGICAL OR BIOLOGICAL WEAPONS CRIME
